Joe convened the meeting at 7:30 am.

MOTION: Leslie T. moved, and Bob seconded, interim requisition for Artisan Plaster for overtime work from

May 1- May 15 which already completed in the amount of \$20,772.

MOTION: Leslie T. moved, and Bob seconded, approval of CO A-038 (PCO 241) to CGM Acoustics for the infill on the gable ends per RFI 251 in the amount of \$3,156.

MOTION: Leslie T. moved, and Bob seconded, approval of CO A-039 (PCO 294) to CGM Acoustics for an added picture rail in the galleria per RFI 550 in the amount of \$3,947.

Paul gave an update on the 10-day schedule drivers. The TCO process was discussed. Currently, the Building Department is working in a good rhythm with Turner. Demolition of the existing auditorium will begin the last week of June. A walk through of existing spaces to determine what materials, in detail, can or should be saved will be done.

There was another discussion about reroofing the choral room. Cost for full reroofing is estimated by Silktown to be \$151,000, which includes the proper tapering of the roof. Patching cost, as yet undetermined, may be less expensive until the Board of Education can reroof the entire roof, but patching risks leakage. How the work will be paid for is still at question. Resolution of the question needs to be resolved as soon as possible to meet an October 1st roof installation deadline.

Ron Matten noted that there are concerns about false fire alarms as well as the aesthetic appearance of the site with the approach of graduation.
