Ben Branyan gave an update on the state reimbursement process.

**Construction Update**. Ty gave an update on construction issues.

There was a discussion about the specified seat wall on the west side of the gymnasium. The seat wall both provides seating and retains soil. Because the seat wall requires footing, it will disturb contaminated soil, incurring additional cost. Turner recommended, and the Building Committee concurred, that direction be given to AMEC not to install the seat wall. Other options are available to accomplish the seat wall functions at lower cost.

There was a discussion about possible revisions to the sound system design and provision of additional conduit, which require boxes in masonry and floor slabs. Although spending a minimum sum of no more than \$5000 met with committee agreement, the BC would like to review the plans with Turner before authorizing additional significant expense.

BOE staff is reviewing the security plan.

<u>The Greenwich Time</u> has requested access to the site. At present, Ty noted that the site is not ready but could be available once stairs are poured. Estimated timing is several weeks, potentially by July 22, when the Building Committee is planning to meet on site in GHS Room 900.
