There was a conversation about the process and documentation for authorizing change orders.

There was a discussion about the procedure for and status of applying for reimbursement payments from OSF (formerly BSF). No applications have been submitted to the state because, for purposes of paperwork submission, all changes to the original project estimated costs aren't fully clear. The issue was referred to the BOE and the BET for resolution.

Raymond Kent, lighting consultant, called in at 8:30 am. There was a discussion about how to reduce costs in theater lighting to meet budget limitations. As wiring will be installed, some fixtures may be added or rented after construction. There is a need to make a decision about wiring and dimming systems, which have a 24-week lead time. Fixtures themselves are off-the-shelf products with a less extensive lead time.
